Experience or understanding of oceans and coastal environment or related field and being in possession of Environmental Management Inspector certificate will be an added advantage. Must have good verbal and written communication skills and the ability to work in a team. Must be computer literate. The incumbent must be able to work independently with minimal supervision under extreme pressure. Be willing to travel and work long hours. Be physically fit.
